### **CURFEW ORDER NOTICE**

# IBERVILLE PARISH, LOUISIANA APRIL 3, 2020

IN ACCORDANCE WITH LA. R.S. 29:730.3(F), I, J. MITCHELL OURSO, JR., IBERVILLE PARISH PRESIDENT, HEREBY DECLARE A PARISH WIDE CURFEW BEGINNING TODAY, APRIL 3, 2020, FROM 9:00 P.M. TO

5:00 A.M. FOR ALL OF IBERVILLE PARISH, INCLUDING THE FOLLOWING MUNICIPALITIES, PLAQUEMINE, WHITE CASTLE, ST. GABRIEL, GROSSE TETE, ROSEDALE AND MARINGOUIN. THIS CURFEW IS NECESSARY TO PROVIDE FOR THE SAFETY AND WELFARE OF ALL CITIZENS OF IBERVILLE PARISH AS OUR STATE AND NATION JOIN TOGETHER TO REDUCE THE SPREAD OF THE COVID 19 VIRUS. IBERVILLE PARISH MUST TAKE THIS ACTION TO HELP PREVENT THE SPREAD OF THIS DEADLY VIRUS.

THIS CURFEW WILL REMAIN IN EFFECT UNTIL 12:00 MIDNIGHT, APRIL 30, 2020 UNLESS EARLIER RESCINDED OR EXTENDED. THIS CURFEW SHALL PROHIBIT AND/OR CONTROL PEDESTRIAN AND VEHICULAR TRAFFIC, EXCEPT EMERGENCY VEHICLES AND PERSONNEL. THIS CURFEW DOES NOT APPLY TO ANYONE GOING TO AND FROM THEIR PLACE OF EMPLOYMENT FOR PURPOSES OF WORK OR ANY OTHER ESSENTIAL BUSINESS ACTIVITY AS SPECIFICALLY DEFINED BY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY.

ALL LAW ENFORCEMENT AGENCIES WITHIN THE JURISDICTION OF IBERVILLE PARISH ARE REQUESTED TO STRICTLY ENFORCE THIS MANDATORY CURFEW ORDER.

ANY PERSON VIOLATING THIS CURFEW ORDER SHALL BE FINED NOT MORE THAT FIVE HUNDRED DOLLARS, OR CONFINED IN THE PARISH JAIL FOR NOT MORE THAN SIX MONTHS, OR BOTH.
